A. Property Acquisition: Nancy Hillegonds reported on a conversation she had with the Recreation Passport Division of the Department of Natural Resources regarding repurposing a parcel of property—that discussion with DNR was no longer relevant based on new developments which are:

Riverwood's Property--

DNR owns and has agreed to sell to SHARA 50 acres located off of 2nd Street between Blue Star Highway and 196.

Purchase price to be determined by DNR

SHARA met the morning of February 20, 2024 to approve the process to purchase property DNR to meet April 1 to approve the sale

SHARA will develop master plan for those 50 acres which might include but not limited to PB courts, dog park, pavilion, etc

Utilities installed -- water and sewer

Property has encumbrances ---

Grant request would be submitted April 1, 2025

SHARA looking for \$1 million grant to level
